She is founder and Director of a social enterprise not-for-profit limited company, Sequeli, which provides training for chairs of mental health investigation, domestic homicide reviews, children's serious case reviews and adult safeguarding serious case reviews.

Gillian is a part-time tribunal judge of the First-tier (Health, Education and Social Care Chamber) Mental Health in England and Wales. She has been appointed as a part-time chair of the new Mental Health Tribunal Service in Guernsey, Sark and Alderney where she has advised on the development of their new Mental Health Law.
