Practice Overview

Jessica specialises in all areas of family law relating to children, including private law and public law cases.

Jessica's public law work often involves serious allegations of injuries and complex medical evidence or allegations of FII. Jessica represents local authorities, Guardian's and parents, and is extremely experienced in cases involving clients with significant vulnerabilities. Jessica appears regularly in the High Court and has recently been in the Court of Appeal on a range of Appeals as part of her public law practice.

Jessica undertakes instructions for private law cases including child arrangements and surrogacy. Jessica has a strong practice in cases involving allegations of domestic abuse and coercive and controlling behaviour. Jessica has been counsel in the two, significant Appeals when the Court of Appeal considered the definitions of domestic abuse and how the family courts should approach such applications. Jessica also appears in the High Court in cases of international child abduction and Wardship.

Jessica has undertaken a significant project advising a foreign government on family law reform.

Jessica also undertakes financial remedies work, with a particular interest in pre and post nuptial agreements.

Jessica is a member of the Commonwealth Lawyers Association and has links to Antigua and Barbuda.

Children (Private Law)

In private law disputes, Jessica is known for her experience and her calm approach in complex cases and those involving parental alienation. Jessica regularly represents parents, grandparents and children. Jessica is experienced in applications for leave to remove from the jurisdiction.

She also advises same-sex couples regarding surrogacy, adoption and child arrangements.

Children (Public Law)

In public law cases, Jessica undertakes issues of non-accidental injuries, fictitious illness, sexual abuse, and other complex cases. She accepts applications under the inherent jurisdiction in respect of children and persons under disability. She is experienced at working on abduction applications to remove from the jurisdiction (convention and non-convention countries).

Jessica is expert at care and adoption cases. In such cases she has frequently represented local authorities, parents, Guardians, and has taken instruction via the Official Solicitor.

Court of Protection

Jessica regularly appears in the Court of Protection.

Family Finance & Property

Jessica is experienced in all areas of financial remedy applications, from pre-proceedings negotiations, onwards through to final hearings. She has also worked on pre-nuptial agreements as well as on drafting and advisory work.

Other Information

Jessica was the Member of Parliament for Erewash 2010 – 2015, and Parliamentary Secretary to the Attorney General, Dominic Grieve QC MP. Whilst in Parliament, Jessica was able to raise awareness on important issues of family law, holding debates on issues such as updating the law on surrogacy and adoption reforms.

Jessica is also a former Chairman of the All Party Parliamentary Group for Pro Bono and opened the family law pro bono law clinic at BPP Law School in 2013. She was made a Fellow of the Westminster Abbey Institute in 2015, following completion of the Fellows' Programme. Her course mentor was The Rt. Hon. The Baroness Elizabeth Butler-Sloss GBE PC.

Jessica was elected as a Bencher of the Hon. Society of Middle Temple in 2018.

Jessica is an approved advocacy trainer through Middle Temple. She teaches advocacy to pupils and teaches family law on the new practitioners' programme.

Jessica has also been a Trustee of The Children's Society.
