## Practice Overview

She has also been involved in a number of cases in the rapidly emerging field of radicalisation.

## **Children (Private Law)**

Lucy regularly acts for parents engaged in complex child arrangements disputes: she often represents parents in cases involving allegations of parental alienation and which may require enforcement proceedings to be brought: she has frequently acted for parents in applications to relocate with their children, either within this jurisdiction or abroad; she also represents children through their rule 16.4 Guardian.

Lucy has a developing practice in cases involving alternative families, particularly in the field of declarations of parentage applications following errors made by fertility clinics and those cases involving the application of the Human Fertilisation and Embryology Act 2008.
