## **Practice Overview**

Marlene is recognised as a leader in her field. ### **Children (Private Law)**

Marlene frequently acts for parents and children in section 8 Children Act 1989 applications, including those which feature serious allegations, non-compliance and enforcement, require a rule 16.4 guardian, involving permission to remove children from England and Wales, and where special guardianship orders are sought. Marlene has significant experience in international cases where child abduction, jurisdiction, and surrogacy arise (including in the application of the Human Fertilisation and Embryology Act 2008).

Marlene also regularly acts for parents and children involved in Hague Convention applications, representing applicants and defenders in the High Court. She also acts and advises in cases involving international movement of children for reasons to do with change of residence and surrogacy.

## **Children (Public Law)**

# **Public Law and Inquiries**

Marlene is in demand as a junior in large-scale public and private inquiries. She is presently instructed as Junior Counsel to the **Covid-19 Inquiry**, focussing on the impact of the pandemic on children and young people across the UK. She is also currently acting as Junior Counsel for a Core Participant in the **Post Office Horizons IT Inquiry**.
