Practice Overview

[Kirsty Horsey](#) is a Professor of Law at Loughborough University and an Honorary Professor at the University of Kent. In 2021-2023 Kirsty undertook two years working in industry as Senior Research Associate at [London Women's Clinic](#) and London Egg Bank and in September 2024 she was elected a Fellow of the Academy of Social Sciences.

Kirsty's long-term research interest focuses on the laws regulating surrogacy. She has worked with external non-profit and charitable organisations to facilitate and encourage reform. One such collaborative project – the SurrogacyUK Working Group on Surrogacy Law Reform – led to the publication of two Research Reports on the state of the law governing surrogacy, together with recommendations for reform, in 2015 and 2018 (see publications list). Professor Horsey is also part of the secretariat for the (currently inactive) All Party Parliamentary Group on Surrogacy.

Her research interests lie primarily in the regulation of surrogacy, other forms of assisted human reproduction and genetic technologies. She is particularly interested in where these areas overlap and intersect with issues in family law, especially the concept of legal parenthood. She also researches within the law of tort, in particular in relation to gendered issues and those obligations based on 'relationship', assumptions of responsibility and/or imbalances of power.
