## Practice Overview

### Children (Public Law)

Sharon has acted pro bono in a number of cases in the Court of Appeal where wider issues of policy in public law proceedings have arisen.

### Children (Private Law)

Sharon has extensive experience of child arrangement disputes within the private law field, and is regularly instructed in intractable child arrangement cases, leave to remove applications as well as having significant experience being instructed on behalf of the child in rule 16 cases.

She frequently represents high-profile clients, often from the sports and entertainment industries with widespread media attention and multi-jurisdictional elements, which requires consideration of reporting restrictions.

## International Family Law
